Exhibitors may sell any and all items that pertain to their business/booth to the general public attending the Show provided they have submitted their **UBI** number on this contract. Any item sold at your booth will be required to have a sales receipt. Exhibitors will be responsible for payment to the State of Washington for All State Sales Taxes collected.

Prior exhibitors will have preferred space allotment based on previous years Contract. All other spaces will be assigned at the discretion of the Snow and ATV Show Director. To the extent possible, all exhibitors will be given the best possible location that will enhance their exposure to people attending the Show. If you would like a phone line for your booth, arrangements must be made with “**CenturyLink**” at least two weeks prior to the show.

As an Exhibitor, I agree to have a representative present at all times during Show hours. The Spokane Winter Knights Snowmobile Club is a non-profit organization and cannot assume liability or responsibility for Exhibitors and/or their merchandise. All machines on display must have the carbide skags removed before being placed in your display area and the gas tank lids taped closed.
